Council member Robert Kraus made a motion to approve the November 13, 2018 Minutes as corrected. The motion was seconded and passed unanimously.

Wray Fire Department – Special Events Permit (Cajun Broil-February 9, 2019)

Wray Fire Department – Special Events Permit (King of the Grill BBQ Competition-March 23, 2019)

Ordinance #611: Amendment No. 1 to Supplemental Agreement for Firm Power Interchange Service Schedule J with Municipal Energy Agency of Nebraska
