PLAN REVIEW FEES

If plan review is required, a plan review fee shall be paid at the time of submitting plans and specifications for review. **Plan review fees shall be equal to sixty-five percent (65%) of the total permit fee for a permit to do the work proposed. When plans are incomplete or changed so as to require additional plan review, an additional plan review fee shall be charged at the rate which has been established.*

1. Valuation is based on unit costs of materials per square foot and on the occupancy classification and type of construction. (See attached Square Foot Construction Costs table.) Remodel projects that include all trades will be calculated at 50% of the unit costs.
2. The City will not perform real estate inspections.
3. The City will not locate property lines. It is the responsibility of the property owner to know where they are.
4. Any person, firm or corporation who violates any provision of the Building Code or any other construction code of the City shall be subject to the penalties found in Chapter 15, Sec. 15.08.050 of the *Wray Municipal Code*.

FEE CALCULATION	
Age of Street Pavement: The age of the right-of-way pavement where excavation occurs shall be the period of time since the right-of-way was constructed, resurfaced, overlaid or reconstructed, measured	

from the fiscal year in which such work was completed to the fiscal year when a permit is issued for the excavation.

Length of Excavation: The fee for longitudinal and transverse excavations in public rights-of-way shall be calculated based on the length of the excavation in linear feet.
